UPDATES AND CLARIFICATIONS REGARDING PENNSYLVANIA'S EMISSIONS INSPECTION PROGRAM

This bulletin addresses changes in Pennsylvania's Vehicle Emissions Inspection Program.

As a result of these changes, 16 counties have been added to the emissions inspection program and the program in the 5-County Philadelphia and 4-County Pittsburgh regions will be modified to include OBD testing by the end of June 2004. PennDOT initiated a staggered rollout as a means of implementing these new program areas and modifications.

All subject vehicles included in this program must have a renewed emissions inspection sticker affixed to the windshield prior to having a renewed safety inspection sticker affixed to the windshield. As a reminder, the safety inspection procedures for vehicles registered in the 25 emissions counties referred to in this bulletin have not changed.

The following 16 expansion counties have been included in the program in the months listed below.

During the rollout period, emissions inspection stations with OBD equipment must use that equipment for all applicable vehicles with a model year of 1996 and newer. Emissions inspection stations with OBD equipment are not permitted to revert back to an ASM/TSI test on vehicles required to receive the OBD test. At the end of each county's rollout period, all stations must be equipped to perform all of the emissions tests required in that county in order to remain an emissions inspection station.

Vehicles registered in the Pittsburgh and Philadelphia regions will be required to have the following emissions inspection performed.

Pittsburgh Region: Allegheny, Beaver, Washington and Westmoreland Counties.
